MEDITERRANEAN IMPLEMENTATION OF EEA ®

Aim of MEDEEA: Achieve the “20-20-20” objectives in the Med regions, through better local energy governance and local energy planning (European Energy Award®-eea and Covenant of Mayors).

Main outputs:

- 25 partners' staff trained
- 73 municipalities involved in 9 regions (representing 1 million people)
- 73 energy teams created (representing 300 people)
- 44 municipalities eea awarded
- 32 Sustainable Energy Action Plan delivered
- joint guidelines – joint policy recommendations

Main effects:

- partners' staff qualified to be able to support municipalities
- municipal workforce better qualified on energy issues
- increase of politicians' energy awareness and integrated policy making
- 44 municipalities invest/commit on energy issues (either soft or hard measures)

Increased knowledge on municipalities needs and features at Med level!!!!!!
